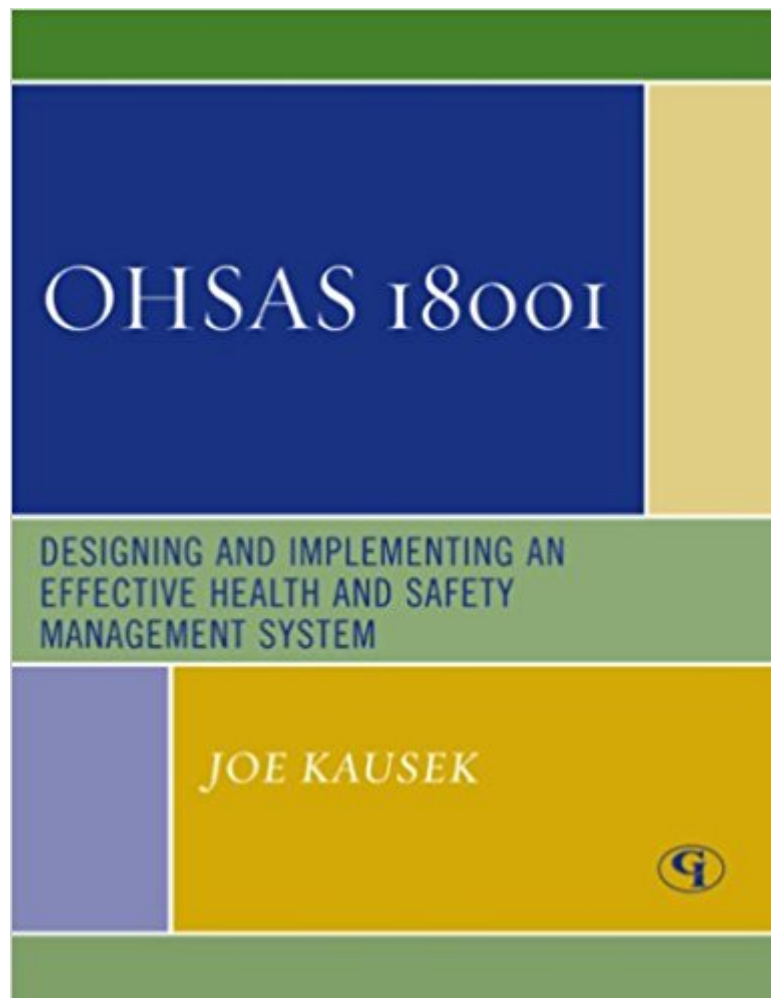

OHSAS 18001 examines each clause of OHSAS 18001, provides thorough explanations, and details the steps needed to build and implement an effective occupational health and safety management system based on the specification. You'll learn how to incorporate all aspects of an effective management system, including core processes like identifying workplace hazards and assessing the risks; key supporting processes used to maintain an awareness of legal requirements, ensure competency of employees, provide an adequate infrastructure, and monitor and evaluate performance; and best procedures for implementing and managing system-supporting processes such as document control, record control, and internal auditing.
