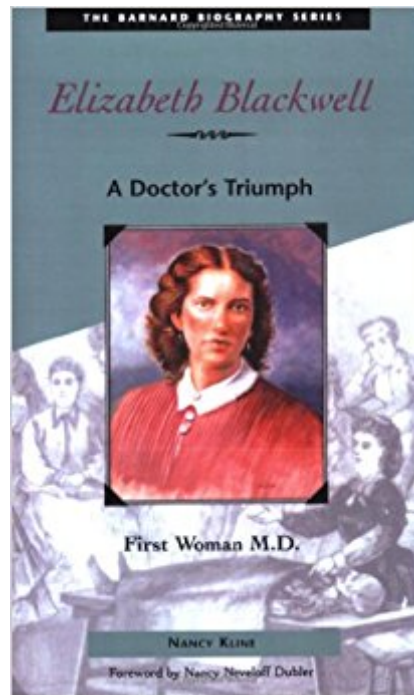

Setting the stage for Blackwell's story is a foreword delineating the limitations of American medicine in the early 1800s and how much women suffered at the hands of male physicians, who practiced without standards. Onto this scene, from a close-knit family of Dissenters who emigrated from England, came a single-minded young woman determined to become a surgeon. A few physicians rallied to her cause, becoming sponsors, but no medical schools would admit her?except, eventually, Geneva Medical College of Western New York, and that was actually the result of a joke. The many personal and professional hurdles that Blackwell had to overcome in order to succeed are clearly put forth in this lively, well-documented narrative. Kline is particularly adept at placing her subject in the context of her social and intellectual milieu, her teaching career, and the community of medicine during her lifetime.
