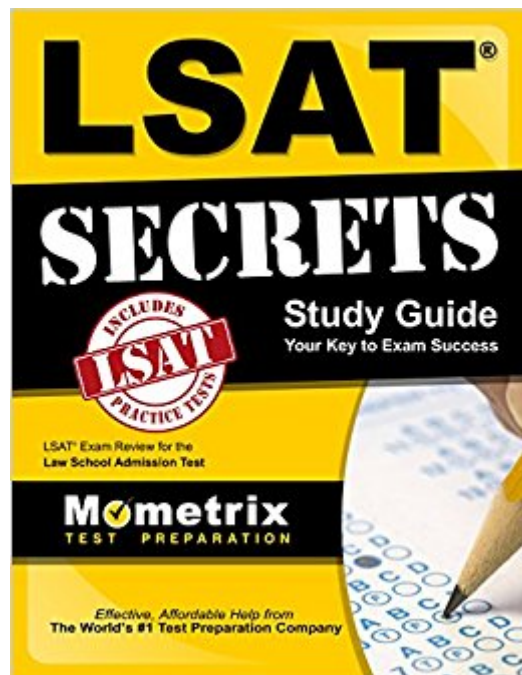

Although real LSAT questions were not advertised, I assumed it would be a great book to read for test taking strategies due the ratings. The first few pages made me second guess the book. Ear plugs are not allowed in the LSAT and leaving this in front of the book can really hurt someone's score if they don't plan accordingly. The organization and examples were subpar. I recommend buying the PowerScore Bibles, LSAT Trainer or Blueprint's material. They can be pricey, but this book does not give a comprehensive review you will need to score greater than a 150. I would not recommend this book.

This book is the longer version of the LSAT Quick Study. The explanations are more thorough, but otherwise, it is exactly the same. Another big difference is that this practice test is a full LSAT test. It has all 4 sections and an answer key, which helped. I think the practice test is a bit easier than the real test though because I suspiciously scored quite a bit higher on this test than on the real practice tests. I give it 3 stars because I already had a few other study guides by the time I bought this one, and I preferred the others. I returned this.

I would definitely recommend any test taker to use this book as a tool and as a study guide to master the LSAT test regardless if the person took the test. It helps in regards to understanding the basics and very self explanatory. Most importantly, this book provides great study techniques, strategies and explanations to why a particular answer is correct, identifies each question and finding ways to help a test taker overcome trap answers and challenges. I decided to pursue other opportunities and try different approaches in mastering the actual test. Therefore, I needed an extra

boost and more tips in test preparation being so that I was familiar with taking the exam and I had every single prep book made. After buying this book, I was confident that this book would help me to succeed in my LSAT journey.
