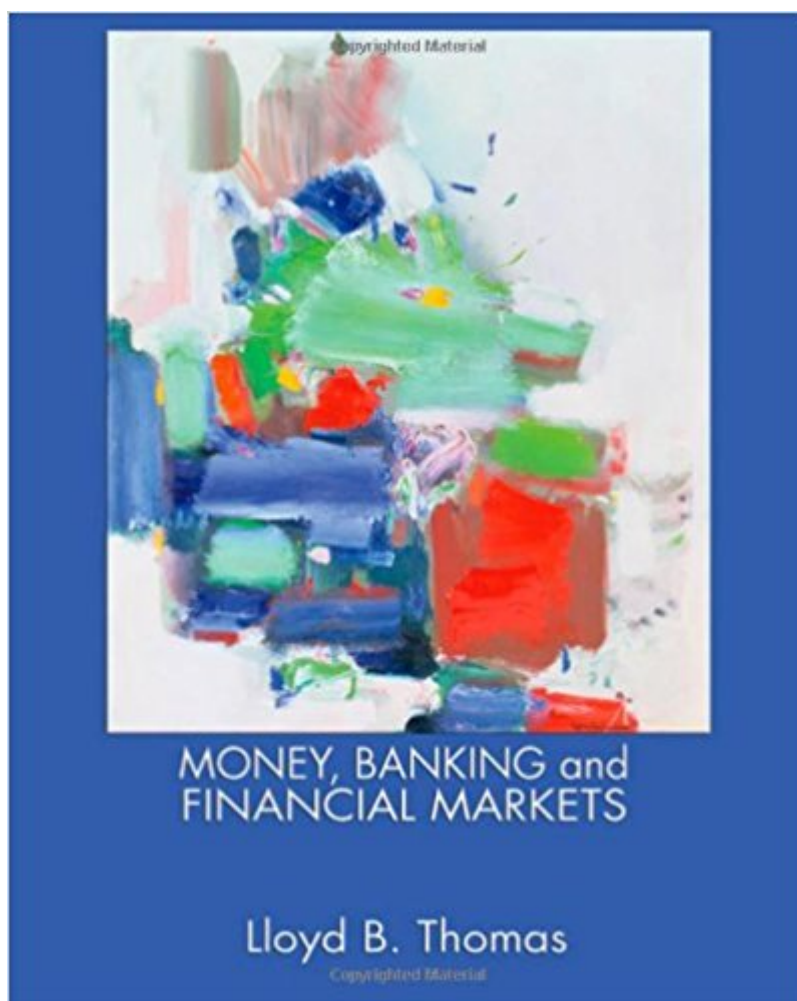

There are not enough visual representations, and the layout leaves a lot to be desired as graphs will be on the next page forcing you to flip back and forth while reading the text to interpret the graphs. The index doesn't have all of the references and I found myself wasting a minute here and there trying to locate specific topics while studying.
